GENERATORS - FOOD VENDORS ONLY – We will be using an approved WHISPER QUIET Generator – Yes / No (circle one). All Generators must be approved by the City of Rosemount Fire Marshall. No modifications to Generators allowed.

Vendors that use electricity must have an approved quick-disconnect electrical panel attached to their trailer or a portable panel that will be inspected by the State Electrical Inspector. No household appliances are NOT allowed. Electrical plug-ins and extension cords must be UL approved and meet requirements of the State Electrical Inspector. **Please contact Pat McMullen at 612-850-6550 (STATE ELECTRICAL INSPECTOR) if you have any questions about your inspection.** All food Vendors must have a special events license from the State of Minnesota Department of Health. **Please call 651-208-4188 to obtain a license 45 days prior to the Mid-Summer Faire.** DO NOT LEAVE YOUR BOOTH SPACE UNTIL AFTER YOU HAVE BEEN INSPECTED.
